AMENDATORY SECTION (Amending WSR 15-03-038, filed 1/12/15, effective 2/12/15)

WAC 388-106-0610 Am I eligible for chore-funded services? To be eligible for chore-funded services you must meet all of the following criteria:

- (1) Be grandfathered on the chore program before August 1, 2001 and have continued to receive chore without a break in service.
- (2) Not be eligible for MPC or COPES.
- (3) Be eighteen years of age or older.
- (4) Have an unmet or partially met need with at least one of the following activities of daily living, as defined in WAC 388-106-0010.

(5) Have net household income (as described in WAC 388-450-0005 and 388-450-0040) not exceeding:

- (a) The sum of the cost of your chore services; and
- (b) One-hundred percent of the federal poverty level (FPL) adjusted for family size.

(6) Have resources, as described in chapter 388-470 WAC, which do not exceed ten thousand dollars for a one-person family or fifteen thousand dollars for a two-person family. (Note: One thousand dollars for each additional family member may be added to these limits.); and

(7) Not transfer assets on or after November 1, 1995 for less than fair market value, as described in WAC ((182-513-1365)) 182-513-1363.

Purpose of the Proposal and Its Anticipated Effects, Including Any Changes in Existing Rules: Under HB [2SHB] 2452 (2012), commonly known as procurement reform, RCW 43.19.185 was repealed. RCW 43.19.185 mandated the development of credit card systems and rules relating to the use of credit cards by state agencies and departments.

While the development of credit card policies and standards are required under HB [2SHB] 2452, credit card rules are no longer required.

In addition, fully developed and operational credit card systems, controls and policies are in place and widely used and followed by state agencies and departments.

Reasons Supporting Proposal: Because of this, chapter 200-370 WAC is no longer relevant. This rule change repeals chapter 200-370 WAC.

Purpose of the Proposal and Its Anticipated Effects, Including Any Changes in Existing Rules: The purpose of this proposal is to eliminate any future conflict or questioning of whether "canola" is a covered commodity by adding the word "canola" to the list of covered commodities. The current rule only lists "rapeseed," which was originally intended to include all varieties of canola and rapeseed, but has in recent years become much more narrow in meaning. This proposal will restore the original intent of the rule, and will provide greater clarity than the current rule language.

Reasons Supporting Proposal: Producers of canola will have clear assurance of protection under chapters 16-237 WAC and 22.09 RCW.

Statutory Authority for Adoption: RCW 22.09.020, chapter 34.05 RCW.

Statute Being Implemented: RCW 22.09.020.

AMENDATORY SECTION (Amending WSR 00-21-043, filed 10/13/00, effective 11/13/00)

WAC 16-237-015 Covered commodities. Commodities covered under chapter 22.09 RCW in respect to storage and/or merchandising shall include wheat, barley, oats, field corn, popcorn, rye, triticale, grain sorghum, soybeans, sunflowers, flax, buckwheat, canola, rapeseed, safflower, millet, mustard, dry peas, dry beans, lentils, malt, and the by-products resulting from conditioning the above commodities.
