The public disclosure commission (the commission) submits this semi-annual agenda for rules under development, in accordance with RCW 34.05.314. The commission is granted rule-making authority by RCW 42.17A.110(1). Possible rule making may include:

1. Informal settlement procedures.

Informal settlement procedures are being revised to establish alternatives to adjudicative proceedings to resolve complaints and enforce chapter 42.17 RCW and Title 390 WAC. The commission has approved draft proposed new and amended rule language. A public hearing will be scheduled for September 2015 or later.

Statute Being Implemented: RCW 34.05.060.
WAC Cite: Chapter 390-37 WAC.

2. Executive director's duties.

The executive director's duties will be updated in conjunction with revising the commission's informal settlement procedures.

Statute Being Implemented: RCW 42.17A.110.
WAC Cite: WAC 390-12-200.

3. Electronic signatures.

The commission will implement chapter 72, Laws of 2015, and eliminate signature cards currently required from individuals who electronically submit reports under the provisions [of] chapter 42.17A RCW.

Statute Being Implemented: RCW 42.17A.245 [42.17A.245]; chapter 72, Laws of 2015.

WAC Cite: WAC 390-19-020 Electronic filing—Mandatory filing.

4. Campaign finance disclosure - independent expenditures.

The commission will revise letter codes campaigns use when disclosing independent expenditures to provide the public with more granular details about those expenditures. CR-101 filed July 16, 2013 (WAC 390-16-041).

Statute Being Implemented: RCW 42.17A.240.
WAC Cite: WAC 390-16-041.

5. Contribution limits.

RCW 42.17A.125 requires the commission, in alternate years, to consider making adjustments to contribution limits and other dollar amounts enacted through I-134 based on changes in economic conditions. The commission expects to begin the 2016 adjustment process in September 2015.

Statute Being Implemented: RCW 42.17A.125 and 42.17A.405.

6. Adjusting the reporting threshold for out-of-state political committees.

The commission must annually adjust the reporting threshold for major contributions disclosed by an out-of-state political committee. This process will likely begin in September 2015.

7. Converting interpretive statements to rules.

The commission plans to continue its initiative to convert long-standing interpretive statements to rules and expects to convert PDC Interpretation No. 01-04, *Participation in Fund Raising Events by State Officials During Legislative Freeze Period*.

WAC 296-17A-6510 Classification 6510, Domestic servants/home care assistants employed in or about the private residence of a home owner, was amended in 2007 to include gardening and caretaker in that class. The policy is amended to reflect that these activities are included in Classification 6510.

In addition, the following clarifying statements are added to the policy:

- All hours for domestic servants during the day or overnight are to be included in the calculation determining if coverage is mandatory.
- The average hourly wage computation may also be applied to determine reportable hours for the domestic servant risk classification.

The purpose of the upland fin-fish hatching and rearing general permit is to regulate the discharge of pollutants from upland fin-fish hatching and rearing facilities into waters of the state. Dischargers who require coverage under this permit include all state and private hatcheries that produce more than 20,000 pounds of fish per year or feed more than 5,000 pounds of feed per month. The permit contains best management practices and effluent limitations and monitoring requirements necessary to protect state water quality.

Chapter 516-26 WAC, Student records. University review of chapter 516-26 WAC, Student records, with possible amendments, including but not limited to WAC 516-26-040 Right to copy education records, 516-26-090(2) directory information, and housekeeping changes. Preproposal to be filed in 2015.

Chapter 516-36 WAC, Use of university facilities—Scheduling; chapter 516-37 WAC, Use of university facilities—Libraries; and chapter 516-34 WAC, Leasing of university property for business purposes. Review and reorganization of the university's facility use and property WACs. Preproposal to be filed in 2015.

Chapter 516-24 WAC, General conduct. Review and possible amendment to chapter 516-24 WAC. Preproposal to be filed in 2015.

Chapter 516-52 WAC, Health and safety. Amendments to WAC 516-52-001 Smoking on campus, to comply with a state initiative that prohibits smoking in public places and workplaces and to address electronic cigarettes and other smoking devices. Preproposal CR-101 was filed February 2010 (WSR 10-05-049) and CR-102 anticipated to be filed in 2015.
