Effective Date: On or after October 22, 2015.

Description: The health care authority in coordination with the department of social and health services intends to submit medicaid SPA 15-0039 in order to update the assignment process for apple health enrollees and clarify the procurement methodology used to obtain additional managed care organizations when necessary. SPA 15-0039 will also add information about the fully integrated managed care program that will be operationalized in southwest Washington in 2016 and statewide by 2020 and the voluntary enrollment process for children in the apple health foster care program that will begin January 1, 2016.

Because the fully integrated managed care program will be providing already covered services, just in a different format, this SPA is expected to have no effect on annual aggregate expenditures.

INTERPRETIVE STATEMENT ISSUED

The department of revenue has issued the following excise tax advisory (ETA):

ETA 3092.2015 - Hazardous Substance/Petroleum Products Tax, Vessels Operating Both in Washington Waters and Outside of Washington

This ETA explains how taxpayers operating vessels in interstate or foreign commerce are liable for both the hazard-

ous substance tax and petroleum products tax on the fuel they consume in Washington waters by providing approved formulas for computing the taxes on the fuel. This ETA is being updated to correct the formulas, clarify how to determine the wholesale price of fuel, and provide an example.

Title: 2015-1: Procedure for Suspension or Revocation of an Inspector's Commission.

Date Issued: October 1, 2015.

Description: This new policy provides the progressive procedures for suspension, revocation, and reinstatement of an inspector's Washington state commission. The purpose of this policy is to ensure uniformity and consistency in managing corrective actions for inspectors that commit a first offense violation(s) and investigation process for violations that may warrant the suspension or revocation of an inspector's Washington state commission.

This policy applies to all inspectors and authorized inspection agencies (AIA) (RCW 70.79.100 through 70.79.-130). If the department finds reason to believe an inspector has violated the boiler and unfired pressure vessel laws chapters 70.79 RCW and/or 296-104 WAC and/or caused imminent danger to the public; the department will execute the procedures outlined in this policy.
