The rate for minor workers under sixteen, pursuant to WAC 296-126-020 (eighty-five percent of the hourly rate required by RCW 49.46.020), will be \$8.10 per hour starting January 1, 2017.

### Announcing a Draft Bridge and Ferry Terminal Washing General Permit for Review and Comment

**Proposed Permit:** The Washington state department of ecology (ecology) is proposing to issue the bridge and ferry terminal washing general permit (permit).

State and federal water quality statutes and regulations do not allow the discharge of pollutants to waters of the state without permit coverage. The activities allowed in the proposed permit present a potential risk for the discharge of pollutants into waters of the state, and therefore require a discharge permit before conducting bridge or ferry terminal washing activities. Ecology issues general permits in place of a series of individual permits when the permitted activities are similar.

**Purpose of the Permit:** The bridge and ferry terminal washing general permit is a national pollutant discharge elimination system (NPDES) permit that allows for the regular maintenance cleaning, preparatory washing, and painting of bridge and ferry terminals and associated over water metal structures, over waters of the state. The activities permitted in the draft permit are to aid bridge inspectors with the Washington state department of transportation (WSDOT) preform in-depth inspections to assess the structural integrity of bridges and ferry terminals across the state. Additionally, cleaning, washing, and painting prolong the integrity and safety of these structures, and this permit allows both WSDOT and local jurisdictions to conduct those activities.
