Purpose of the Proposal and Its Anticipated Effects, Including Any Changes in Existing Rules: To amend effective dates in WAC 434-120-035 when paper filings will no longer be accepted (April 30, 2017) and online filing will be mandated (May 1, 2017). The online filing system is still under construction and therefore, the online filing date of May 1, 2017, is not possible.

WAC 434-120-035 Mandatory filing online.

All charitable organizations and commercial fundraisers filing registrations and renewals, and charitable trusts filing renewals, will be required to file using the secretary of state's online filing application as of ~~May 1, 2017~~ January 1, 2018. Except for initial trust registrations, paper documents will not be accepted after ~~April 30, 2017~~ December 31, 2017.

Reasons Supporting Proposal: The online filing system is not yet available.

Statutory Authority for Adoption: RCW 11.110.070, 19.09.020, 19.09.541, 19.09.560, 43.07.120.

Statute Being Implemented: Chapters 19.09, 11.110 RCW.

Purpose of the Proposal and Its Anticipated Effects, Including Any Changes in Existing Rules: This proposal amends WAC 16-301-010 by adopting the following standards regarding the certification or testing of seed: The 2016 version of the Association of Official Seed Certifying Agencies (AOSCA) rules and procedures, the 2016 version of the Association of Official Seed Analysts (AOSA) rules for testing, and 7 C.F.R. Part 201 "Federal Seed Act Regulations," revised as of January 1, 2016.

Reasons Supporting Proposal: Both AOSCA and AOSA have updated the publications adopted by reference in this rule, yet the rule still references the 2013 editions of these publications. Adopting the most recent version of the AOSCA and AOSA publications and the Federal Seed Act will assure Washington state certified seed is in compliance with national standards designed to promote uniformity and consistency in the certification of agricultural, vegetable and flower seed. These amendments are proposed for expedited adoption under RCW 34.05.353 (1)(b).

Statutory Authority for Adoption: RCW 15.49.005, 15.49.310, 15.49.370(3), chapter 17.24 RCW.

Statute Being Implemented: Chapters 15.49 and 17.24 RCW.
