Pursuant to this decision and RCW 82.08.0254, 82.12.0255, and 82.32.733, effective October 1, 2018, the department will require a remote seller to collect retail sales or use tax on all taxable sales sourced to Washington if it exceeds \$100,000 in gross retail sales or two hundred retail transactions in the state during the current or prior calendar year. Therefore, this rule needs to be updated to reflect these changes to who is required to collect use tax on taxable retail sales into Washington.
