Reasons Why Rules on this Subject may be Needed and What They Might Accomplish: Required action district (RAD) process and rules provide, per statute, additional supports to districts and schools with persistent challenges in demonstrating progress in improving outcomes for students. The RAD process was originally designed under the federal No Child Left Behind Act, which has since been reauthorized as the Every Child Succeeds Act. Some changes to RAD are required to align the state-directed RAD process with the new federally required accountability framework.

The board has filed a preproposal statement of inquiry to provide notice of its intent to engage in rule making regarding this subject. The board is also considering creating a new section in chapter 246-847 WAC for applicants that hold an expired license in another state and are seeking Washington licensure.

Statutes Authorizing the Agency to Adopt Rules on this Subject: RCW 18.59.130.

Reasons Why Rules on this Subject may be Needed and What They Might Accomplish: WAC 246-847-120 has potentially conflicting and confusing language within the section, making it difficult for credentialing staff and stakeholders to fully understand and implement the requirements for applying as an applicant from an unrecognized education program. Further, with the recent revisions to the definitions, continuing education, and licensing requirements under WSR 18-09-032, a route to licensure for applicants expired in another state was inadvertently removed. By creating [a] new section in chapter 246-847 WAC, the board is proposing to reinstate this route to licensure that was removed.

Subject of Possible Rule Making: Chapter 16-228 WAC, General pesticide rules, the department is considering modifying provisions regarding pesticide examinations in order to offer computer-based testing services.

Statutes Authorizing the Agency to Adopt Rules on this Subject: RCW 15.58.040 and 17.21.030.

Reasons Why Rules on this Subject may be Needed and What They Might Accomplish: The department oversees a licensing and continuing education program for more than twenty-eight thousand pesticide applicators, dealers, consultants, and structural pest inspectors. As part of the licensing process, the department administers pesticide exams to ensure that individuals and businesses that apply, sell, or consult about pesticide products have the knowledge to do so in a safe and effective manner. Currently, exams are offered in paper form at limited locations on limited dates and are required to be scored manually. The department is considering moving to a computer-based testing environment where applicants can take exams at testing facilities throughout the state. Offering computer-based exams at more facilities throughout the state will make completing the exam step in the licensing process more efficient, convenient, and accessible for applicants. In order to offer this service, the department is considering utilizing a third party vendor to conduct computer-based exams. The department may need to revise current rule language to facilitate the use of computer-based testing, including but not limited to raising and restructuring exam fees.
