The project actively engaged stakeholders and agencies in comparing existing grapevine pest quarantines, developing a common pest list, and identifying universally acceptable cultural mitigations for common pests. These changes are being made as a result of the working groups' suggestions and a petition for rule making from the Washington Winegrowers Association. The quarantine revisions will standardize requirements for the movement of certified grapevines between Pacific northwest states, and strengthen protection of our regional grape and wine industry.
