Title of Rule and Other Identifying Information: Repeal of expressive activities sections.

Purpose of the Proposal and Its Anticipated Effects, Including Any Changes in Existing Rules: New rules relating to the use of campus facilities by campus and noncampus groups for engaging in free speech and other expressive activities have been adopted.

Reasons Supporting Proposal: New chapter 106-141 WAC has been adopted relating to expressive activities on campus, so chapter 106-140 WAC needs to be repealed.

Statutory Authority for Adoption: RCW 28B.35.120 and Administrative Procedure Act, chapter 34.05 RCW.

Rule is not necessitated by federal law, federal or state court decision.

Name of Proponent: Central Washington University (CWU), public.
