Description: The health care authority (the agency) is submitting an amendment to the 1915(b) waiver to reflect the next implementation of the integration of mental health and substance use disorder services (collectively known as "behavioral health") into an integrated managed care (IMC) program under contract with apple health managed care organizations (MCO).

On January 1, 2020, the agency will implement IMC in the remaining regional service areas (RSA), which include Great Rivers, Salish and Thurston Mason. These RSAs consist of Thurston, Mason, Lewis, Grays Harbor, Wahkiakum, Cowlitz, Pacific, Kitsap, Jefferson, and Clallam counties. At this time, coverage previously provided by behavioral health organizations (BHO) for specialty behavioral health services will be transferred to MCOs across all regions of the state.

Once IMC is statewide, a waiver will no longer be necessary for BHOs. This amendment removes BHO program elements from the waiver. The waiver will continue to authorize enrollment into the behavioral health services only program for individuals who are not mandatorily enrolled in IMC. These remaining enrollees will continue to receive physical health medical services through other delivery systems, such as the agency's fee-for-service system, medicare, or primary care case management.

This waiver is expected to increase annual aggregate expenditures by four percent. Total expenditures for years one through five of the waiver are anticipated to be \$2,733,962,207.

Document Title: Preventing and Addressing Discrimination in Student Discipline, Guidelines for implementing Washington's Equal Educational Opportunity Laws: Chapters 28A.640 and 28A.642 RCW and 392-190 WAC.

Subject: Nondiscrimination in K-12 public schools. Effective Date: October 11, 2019.

Document Description: In accordance with RCW 28A.640.020 and 28A.642.020, the office of superintendent of public instruction (OSPI) has published guidelines for preventing and addressing discrimination in student discipline. These guidelines supplement chapter 392-190 WAC and guide OSPI's interpretation and enforcement of state nondiscrimination laws in Washington's K-12 public schools. To that end, public schools should consider these guidelines when developing, assessing, and revising discipline policies, procedures, and practices. Public schools should also carefully review these guidelines when investigating and responding to complaints alleging discrimination in student discipline.

The department of retirement systems uses administrative factors to calculate retirement benefits. Some of the ways factors are used include calculating the actuarial equivalent for early retirement and joint retirement options to provide approximately the same lifetime benefit as a normal singlelife retirement. Optional costs are also based on factors when restoring withdrawn and optional service credit past the deadline, and when purchasing additional service or an annuity. These administrative factors are periodically reviewed by the office of the state actuary (OSA). OSA recommends that the administrative factors be updated, if necessary, when the underlying demographic or economic assumptions change.

As a result of changes to the economic assumptions adopted by the pension funding council and the law enforcement officers' and firefighters' [plan] 2 board during the 2017 interim, OSA has recommended revisions to the actuarial factors used by the department. The proposed actuarial factors are available for review at http://www.drs.wa.gov/ administration/administrative-factors/default.htm.

PUBLIC NOTICE Announcing the Reissuance of the Vessel Deconstruction General Permit

On November 6, 2019, the Washington state department of ecology (ecology) is reissuing the vessel deconstruction national pollutant discharge elimination system and state waste discharge general permit (permit). The permit becomes effective on December 6, 2019, and expires on December 5, 2024.

State and federal water quality regulations do not allow the discharge of pollutants to waters of the state without permit coverage. Activities associated with the deconstruction of vessels can result in the discharge of potential pollutants, and therefore require a discharge permit before these activities may occur. Ecology issues general permits in place of a series of individual permits when the permitted activities are similar.

Purpose of the Permit: The permit provides statewide coverage for the deconstruction of vessels over water, including deconstruction activities that occur on a drydock, barge, or pier. The permit does not provide coverage to facilities that are covered under the boatyard general permit or an individual permit that allows this activity. Vessel deconstruction does not include disturbances related to vessel retrieval. The purpose of the permit is to control the discharge of pollutants from stormwater, drydock floodwater, and nonstormwater discharges associated with vessel deconstruction activities into waters of the state. Under federal and state water quality laws (federal Clean Water Act and state Water Pollution Control Act); a permit is required for the discharge of these wastewaters. Entities that conduct vessel deconstruction activities over water and discharge wastewater either directly or indirectly to waters of the state must obtain permit authorization for their discharge.

Public Notice Process and Comments: Ecology accepted public comments on the draft permit, fact sheet, and related documents from **August 21**, **2019**, **through September 27**, **2019**. Ecology held a public workshop and hearing in Seattle, Washington on September 24, 2019, and an online webinar on September 23, 2019. Ecology received written comments during the public comment period. The comments and ecology's responses are included in Appendix C of the fact sheet.

Applying for Coverage Under the Permit: Facilities that have already applied for coverage by June 3, 2019, and are covered under the existing permit will be covered under the new permit. New or unpermitted facilities may obtain coverage under the permit by submitting a complete permit application to ecology and meet all applicable public notice and State Environmental Policy Act requirements (WAC 173-226-200).
