Subject of Possible Rule Making: The board of pilotage commissioners (BPC), in consultation with ecology, is beginning a rule making to amend chapter 363-116 WAC, Pilotage rules. Chapter 363-116 WAC describes the training, licensing, and regulation of Washington state maritime pilots to ensure safe pilotage. Chapter 363-116 WAC also describes tug escort requirements for oil tankers in Washington waters.

The rule making will amend WAC 363-116-500 and, if needed, add new sections to chapter 363-116 WAC. The rule making will consider 2019 legislative changes made to chapter 88.16 RCW (Pilotage Act) through the passage of ESHB 1578. The rules will be designed to achieve best achievable protection, as defined in RCW 88.46.010, and will be informed by other considerations in ESHB 1578. The rule making will:

- Describe tug escort requirements for the following vessels operating in the waters east of the line extending from Discovery Island light south to New Dungeness light and all points in the Puget Sound area:
  - o Oil tankers of between 5,000 and 40,000 deadweight tons.
  - o Articulated tug barges (ATB) and towed waterborne vessels or barges greater than 5,000 deadweight tons that are designed to transport oil in bulk internal to the hull.
- Specify operational requirements for tug escorts, where they are required.
- Specify functionality requirements for tug escorts, where they are required.
- Consider the existing tug escort requirements applicable to Rosario Strait and connected waterways to the east, established in RCW 88.16.190 (2) (a) (ii), including adjusting or suspending those requirements, as needed.
- Describe exemptions to tug escort requirements, including whether certain vessel types or geographic zones should be precluded from the escort requirements.
- Make other changes to clarify language and make any corrections needed.

Statutes Authorizing the Agency to Adopt Rules on this Subject: RCW 88.16.260 Board of pilotage commissioners authorized to adopt rules in consultation with other entities—Tug escorts.

Reasons Why Rules on this Subject may be Needed and What They Might Accomplish: Through ESHB 1578, codified in chapter 88.16 RCW, the legislature established tug escort requirements for certain oil tankers, ATBs, and towed waterborne vessels in Rosario Strait and connected waterways to the east. ESHB 1578 directs BPC, in consultation with ecology, to adopt rules regarding tug escorts in Puget Sound for oil tankers, ATBs (as defined in RCW 88.16.260), and towed waterborne vessels or barges by December 31, 2025.

A catastrophic oil spill in the Puget Sound could cause damage to endangered southern resident killer whales and other species, damage tribal, commercial, and recreational fishing, and cause economic and public health consequences in Washington state. The escort require-

ments addressed by this rule making are intended to provide preventative measures to reduce the risk of a major oil spill.

Other Federal and State Agencies that Regulate this Subject and the Process Coordinating the Rule with These Agencies: Federal and state agencies that regulate vessels transporting bulk oil include: United States Coast Guard, Environmental Protection Agency, Canadian Coast Guard Vessel Traffic Services, Washington state department of ecology, Washington state department of fish and wildlife, Washington state department of transportation, British Columbia Ministry of Environment and Climate Change Strategy, Oregon Department of Environmental Quality, California Department of Fish and Wildlife Office of Spill Prevention and Response, Alaska Department of Environmental Conservation Spill Prevention and Response, Transport Canada, and Pacific Pilotage Authority. Ecology will notify and solicit input from these federal and state agencies, and other stakeholders throughout this rule-making process.

Process for Developing New Rule: BPC will follow the standard process for the adoption of rules under the Administrative Procedure Act (chapter 34.05 RCW).

It is named after Sam Martinez, a freshman at Washington State University who died of alcohol poisoning at a fraternity party in November 2019. The new law updates the definition of hazing and requires institutions of higher education to implement antihazing programming for employees and students. It also requires institutions of higher education (IHEs) to publish an annual report identifying student organizations, athletic teams, and living groups found responsible for engaging in hazing.

The examining board of psychology (board) will consider amending WAC 246-924-010, 246-924-043, 246-924-046, 246-924-047, 246-924-049, 246-924-053, 246-924-056, 246-924-059, 246-924-070, 246-924-100, 246-924-493, and 246-924-495, and possibly creating and repealing sections in chapter 246-924 WAC. The board will consider amending licensure requirements and making changes: (1) For consistency with the American Psychology Association (APA) and other accreditation standards; (2) to address new national examination options; (3) to address concerns with minimum competency; (4) to update requirements for supervised experience; (5) to address the role of remote technology and telepsychology in the profession; (6) to clarify the application process and requirements; (7) to consider additional options for sanctions; and (8) to address any other issues as appropriate. The board may also consider housekeeping changes to clarify and streamline these sections of rule as appropriate.

This rule making is a continuation of discussions with interested parties and rule-making work done under WSR 22-04-055. Because the board received comments from the public on issues beyond the scope of the initial rule making, the board is filing a new CR-101 to open additional rule sections and consider additional topics.

This rule provides guidance on the tax application of the statutes, the filing and reporting obligations, and other taxes (real estate excise and timber tax) that may apply to this industry.
