- Add adult chiropractic services as a medicaid service. Currently, only children under age 21 are eligible for chiropractic services under the early and periodic screening, diagnostic, and treatment (EPSDT) benefit.
- Add acupuncturists as medicaid providers, enabling them to provide and bill for certain acupuncture services.
- Add certified behavioral health support specialists (BHSS) as medicaid providers in compliance with SB 5189. BHSS deliver brief, evidence-based interventions that include behavioral health, and must be under the supervision of a state credentialed provider whose scope of practice includes assessment, diagnosis, and treatment of identifiable mental and behavioral health conditions.

As a result of a recent office of financial management directive, HCA is pausing implementation of coverage for adult chiropractic and acupuncture services planned for January 1, 2025. Therefore, SPA 24-0013 is being revised to remove acupuncturists and adult chiropractic services; coverage for chiropractic services provided under the EPSDT program will remain unchanged. SPA 24-0013 will now address only the addition of BHSS as medicaid providers effective January 1, 2025.

SPA 24-0013 is expected to increase the annual aggregate expenditures/reimbursement/payment for BHSS by \$619,000.
