INTERPRETIVE STATEMENT ISSUED

The department of revenue has issued the following excise tax advisory (ETA):

ETA 3044.2022 Use Tax Modification to Aircraft Dealers

This ETA explains the use tax liability of an aircraft dealer upon aircraft acquired and held in stock for resale, where such aircraft is also used for charter flights or student training programs. This new adoption of ETA 3044.2022 contains only two technical corrections. Specifically, in the last paragraph RCW 82.12.010(2) has been deleted and replaced with the correct section, RCW 82.12.010(7). Also, in the last paragraph a typo is corrected, deleting the word "Retail" because the word appears twice in a row.

Description: The health care authority (HCA) intends to submit Medicaid SPA 22-0006 in order to implement a new PCCMe program for American Indian and Alaska Native Medicaid beneficiaries. This program will expand options for Indian health care providers (IHCPs) looking to provide and be adequately reimbursed for provision of the following limited case management benefits:

1. Provision of intensive telephonic case management.
2. Provision of face-to-face case management.
3. Development of enrollee care plans.
4. Provision of enrollee outreach and education activities.
5. Operation of a customer service call center.
6. Implementation of quality improvement activities including administering enrollee satisfaction surveys or collecting data necessary for performance measurement of providers.
7. Coordination with behavioral health systems/providers.
8. Coordination with long-term services and supports systems/providers.

SPA 22-0006 is expected to increase the annual aggregate reimbursement to IHCPs who elect to participate in the PCCMe program. The Washington state legislature appropriated \$3,000,000 for this program starting in state fiscal year (SFY) 2023. The program is anticipated to be fully implemented in SFY 2025, with an appropriation of \$46,000,000.

Subject: Washington State Medicaid Transformation Project (MTP) waiver—Notice of MTP waiver renewal application and public comment period.

Effective Date: If approved, the MTP waiver renewal will begin January 1, 2023, and end December 31, 2027.

The Washington state health care authority (HCA) will submit a five-year MTP waiver renewal request to the Centers for Medicare and Medicaid Services (CMS). MTP is Washington state's Section 1115 Medicaid demonstration waiver from CMS.

The state is in the last year of the current MTP waiver, which ends December 31, 2022. If approved, the waiver renewal will begin January 1, 2023, and end December 31, 2027.

The waiver renewal will provide an additional five years for Washington state to continue to develop projects, activities, and services that improve Washington's health care system. By renewing MTP, the state can continue:

- Expanding coverage and access to care, ensuring people can get the care they need.
- Advancing whole-person primary, preventive, and home- and community-based care.
- Accelerating care delivery and payment innovation focused on health-related social needs.
