Description: The health care authority (HCA), in conjunction with the aging and long-term support administration (AL TSA) of the department of social and health services (DSHS), intend to submit medicaid SPA 23-0011 in order to adjust agency providers and consumer directed employer rates based on negotiated increases and an estimated decrease in the IRS mileage reimbursement rate. At this time, the IRS has not released the 2023 mileage reimbursement and the below rates are based on an estimated decrease from \$0.625 to \$0.59 per mile. SPA 23-0011 is expected to:

- Increase the hourly rate of agency providers by 1.5 percent, an expected weighted average increase of \$0.52.
- Decrease the hourly rate of consumer-directed employers by 0.3 percent, an expected weighted average decrease of \$0.12.

SPA 23-0011 is in the development process; therefore, a copy is not yet available for review. HCA and DSHS would appreciate any input or concerns regarding this SPA. 1. **Water Typing System.** The board has been engaged in rule development to establish a permanent water typing system. Elements to include in the rule are ongoing. The board may initiate rule making in late 2023.

2. **Type Np Water Buffer.** The board may initiate rule making in late 2023 on Type Np Water (nonfish perennial) riparian management zone buffers in chapter 222-30 WAC.

3. **Marbled Murrelet.** Based on recommendations of the Wildlife Working Group, the board may consider rule making to amend critical habitat rules for marbled murrelet in chapter 222-16 WAC.

4. **Water Typing Lidar Map-based Model.** The board confirmed a lidar map-based model as a goal for the permanent water typing system rule. The board may engage in rule making when there is sufficient statewide lidar coverage.

Purpose of the Permit: The permit provides coverage for the conditional use of pesticides, marker dyes, and other chemicals to manage and eradicate aquatic plants and algae in irrigation canals that flow into surface waters of the state of Washington. Under federal and state water quality laws (Federal Clean Water Act and State Water Pollution Control Act), a permit is required for the discharge of these wastewaters. Irrigation districts, reclamation districts, water companies, and similar entities that discharge wastewater either directly or indirectly to waters of the state must obtain permit authorization for their discharge.

Applying for Coverage under the Permit: Facilities that have already applied for coverage by December 17, 2016, and are covered under the existing permit, are covered under the new permit. New or unpermitted facilities may obtain coverage under the permit by submitting a complete permit application to ecology and satisfying all applicable public notice and State Environmental Policy Act (SEPA) requirements (WAC 173-226-200).
